**CERTIFICATION OF
DELBERT JACKSON**

I, **Delbert jackson**, of full age and of sound mind, hereby certify as follows:

1. As such, I make this Certification based upon my personal knowledge.

2. I was born on **04 12 1954**.

3. I was employed as a **electronic tech3** until the year **01 2005**, at which time I retired.

4. In or around the year **spring 1998**, I was diagnosed by **dr slevin** with Parkinson's disease.

5. At first, my doctor treated my condition with **amtebedine**,requip,artaine,congentine,myrapex ,tryhexphenadyl and some others canr recall, presently.

6. Subsequently, in the year **2002**, in the absence of any other hope for a cure for my Parkinson's disease, I enrolled in a **PHASE I or** clinical trial being conducted by Amgen, Inc., the defendant in this matter.

7. The trial's **UNIVERSITY OF KENTUCKY** location was supervised by renowned scientists **GASH, SMITH, AND DR. SLEVIN**

8. Prior to the surgery, Dr. **SLEVIN** and I engaged in the informed consent

process.

9. Thereafter, I signed the informed consent document, evidencing my agreement to participate in the research.

10. I agreed to take the substantial risks of participation in the trial because I knew of the devastating progressive nature of my disease and because I knew that I would receive in return not only the potential benefit of a cure but the knowledge that I was contributing to the greater good and the advancement of medicine.

11. Subsequently, on **APRIL 02 2003**, I had holes drilled in my skull, had the pumps surgically implanted in my abdomen, and had catheters threaded under my skin from my abdomen to my brain.

12. Each of these procedures was time-consuming, painful, and emotionally trying for me, as well as for my MOTHER CLARA and my children **BROTHERS**.

13. My first dose of GDNF was received on **LAST OF APRIL**, with my second dose being received on **MAY**, my third dose being received on **JUNE**, my fourth dose being received on **JULY**, my fifth dose being received on **AUGUST**, and my sixth and dose being received on **SEPTEMBER, OCTOBER, NOVEMBER, DECEMBER, JANUARY, FEBURARY, MARCH FOR PHASE 1. PHASE 2 APRIL, MAY ,JUNE, JULY, AUGUST, SEPTEMBER, OCTOBER, NOVEMBER OF 2004..**

14. I expected to continue receiving doses of the drug indefinitely.

15. I experienced significant improvement after receiving GDNF.

16. Indeed, for the first time in years, I had hope for an end to the misery that is Parkinson's disease.

17. I had significantly more on time with less medication and more relief. Had a better general overall feeling, able to have expressions, could exercise and work a lot better. Some days would forget to take meds because of good feeling. Gained smell, taste, and hearing increased tremendously, hear better than any other time in my life, had most energy ever had in my life.

18. In fact, I was able to **work and hold down job better, all tasks that I tried was lots better and faster, and all physical activities were not a chore but easy to do.**

19. Then, suddenly, in September 2004, I was told that I would not be able to receive the drug anymore because Amgen had shut down the study, and I was given no more doses of the drug.

20. Since GDNF was withdrawn from my system, I have **gradually fallen back into the days of old suffering loss of ability to function when under normal conditions .and sometimes more than before.**

21. I certify under penalty of perjury under the laws of the United States of America that the foregoing statements are true and based upon my personal knowledge. I am aware that if any of the foregoing statements are false, I may be subject to punishment.
